REQUIREMENTS:

- Images: 4 (a booth shot is required)
- Jury application fee: \$25 non-refundable. Make check payable to AFA
- Application deadline: June 1, 2010 Midnight CST

ABOUT THE FESTIVAL: The Mayslake Peabody Estate Fine Art Fair is situated in the very sophisticated residential area of Oakbrook and Hinsdale. Crowds expected are fairly sophisticated and knowledgeable about art.

IMAGES: Your application must include 4 images: 3 images must be of individual pieces that accurately represent the body of work to be exhibited, and 1 booth shot. The booth image should have no visible name, logo, or insignia. Work shown in images must be representative of current work (no more than five years old).

THE JURY PROCESS: The decision of the jury is based solely on the images and is final. A waitlist of additional artists is used for replacements purposes.

Prints are allowed in a separate bin and labeled as reproductions and should not be more than 30 % of the work shown.

No reproductions may be hung. On-site committee will enforce this policy.

Artists may only sell work in the media category in his or her submitted images.

Artist must be present during the entire event.

BOOTH SET UP AND SPACE: Each exhibitor has a 10x10 space with ample storage behind. The event takes place on a grass surface. The booth should have sufficient weights or be anchored on the ground. Not all booth locations are perfectly level due to slight surface variations.

BOOTH FEE: \$150, double booth display available based on earliest date of this application.

AMENITIES:

- Nearby hotel accommodations and support services (restaurants, gas stations, shopping).
- Central location with plenty of public parking.
- Artists separate parking lot.
- Check-in package, booth sitters, load and unload from parking. Assistance available with golf carts.
